
The journey to becoming an NPO started around 2 years back. During 2020 AGM it was decided to make Nihon Kairali an NPO.

Nihon Kairali : NPO




- Nihon Kairali is registered as Ippan Shadan Hojin- Non Profit Type(一般社団法人) NPO on 24th Nov, 2021
